Other Business Activities

Hannah Stanley is also an insurance agent licensed to sell insurance products. Hannah Stanley spends 5% of her time in this role. A conflict of interest exists because these services pay a commission, which conflicts with the IAR's fiduciary duties. NWWA does not require its IARs to encourage clients to implement investment advice through our insurance product recommendations. Clients have the right to implement insurance product recommendations through the insurance agency and agent of their choice. We require that all IARs disclose this conflict of interest when such recommendations are made. We also require IARs to disclose that the client has the right to purchase recommended products from individuals not affiliated with us.

Hannah Stanley is a registered representative licensed to sell securities. As a registered representative of an unaffiliated broker-dealer, Hannah Stanley spends 2% of her time in this role. Hannah Stanley may earn additional compensation in the form of commissions for the sale of general securities products such as stocks, bonds, mutual funds, exchange-traded funds, and a variable annuity to investment advisory clients. As such, Hannah Stanley may suggest that you implement investment advice by purchasing securities products through a commission-based account introduced through our unaffiliated broker-dealer in addition to an investment advisory account. In the event that you elect to purchase these products through our unaffiliated broker-

dealer, Hannah Stanley, in the capacity as a registered representative, our unaffiliated broker-dealer will receive the standard and customary commission compensation in connection with the particular product purchased. Clients have the right to implement the recommendations through the broker-dealer and registered representative of their choice. We also require IARs to disclose that the client has the right to purchase recommended products from individuals not affiliated with us.
