Other Business Activities

Heath Stanley is also an insurance agent licensed to sell insurance products. He spends 5% of his time in this role. A conflict of interest exists because these services pay a commission, which conflicts with the IAR's fiduciary duties. NWWA does not require its IARs to encourage clients to implement investment advice through our insurance product recommendations. Clients have the right to implement insurance product recommendations through the insurance agency and agent of their choice. We require that all IARs disclose this conflict of interest when such recommendations are made. We also require IARs to disclose that the client has the right to purchase recommended products from individuals not affiliated with us.

Heath Stanley is 100% owner of the real estate firm ReModern Homez, LLC. He started this activity in June 2013 and spends 4-6 hours a month on this activity.

Mr. Stanley is 100% owner of the real estate firm Roma Properties, LLC. He started this activity in July 2014 and spends 1 hour a month on this activity.

Mr. Stanley is a managing member of NWA Pizza, LLC – Papa John's (80%). He started this activity in December 2014 and spends 10 hours per week on this activity.

Mr. Stanley is 100% owner of Guapo Management, LLC. He started this activity in August 2017 and uses the company strictly for allocating expenses for accounting purposes.

Heath Stanley is Co-Owner/Manager (50%) for New Wave Ventures, LLC in Springdale, AR since 12/2020. This is a non-investment related business that is a passive entity. It is a holding company for the building where New Wave Wealth Advisors, LLC operates. He devotes approximately 1 hour per month with 0 hours during trading.

Heath Stanley is Managing Member (50%) of Toro Properties. LLC in Fayetteville, AR since 5/2024. This is a non-investment related business. It is a rental property occupied by daughters. He devotes approximately 2 hours per month with 0 hours during trading hours.

Altogether, the income Mr. Stanley earns from the above activities represents more than 10% of his total income.

Mr. Stanley does not receive any additional compensation for advisory services.
